Equipment Policies

Minimum Equipment List

The following is a list of compulsory equipment needed when participating in a club approved dive:

- a) Current and up-to-date log book and certification card,
- b) Constant pressure gauge,
- c) Depth gauge,
- d) Bottom timer,
- e) Buoyancy compensation device must be worn on all club dives,
- f) Snorkel.
- g) Whistle,
- h) Dive knife,
- i) Dive light when specified by the dive coordinator;
- j) Dive flag and float as required,
- k) A safe second is required to do dives beyond the 60-foot level. (it would be preferable that a safe second be used by all divers on all dives, no matter the depth)

Dive coordinator Equipment Inspection

The dive coordinator has the right if not the obligation to prevent a diver from participating in the club approved dive if any one piece of the "compulsory diving equipment" is absent or defective.

Entry Point

All divers under a club activity must enter the water at the dive coordinator's designated location.
